



The City of Gretna is hosting their third Puzzles & Pie competition on April 27th, 2025. The event will be held at Heavy Brewing from 11:30 - 3:00 pm with the game starting promptly at 1pm. Teams of four (4) will compete to be crowned the Puzzles & Pie Champion! Each team will be given identical 500-piece puzzles to complete.

Whichever team finishes the puzzle first or has the most completed at the end of the allotted time wins a PRIZE.

### Team information

Teams of four (4) may register. Any team with a person of 12 years of age or younger must have an adult as a member of the team. This competition is for anyone in the Gretna area!

### Entry fee/registration

Entry fee per team is **\$60** and covers the cost of the puzzle (you keep), two (2) 12-inch pizzas, and four (4) non-alcoholic drinks. Entry form and non-refundable fee must be received at Gretna City Hall, 204 N McKenna Ave, or at Heavy Brewing, 20333 Patton St, no later than **Friday, April 11th by noon**. Entry form/fee may be delivered in person or mailed.

### Competition location

### Entry Conditions and Rules

- An entry form must be filled out and returned to the Gretna City Hall at 204 N McKenna Ave, or at Heavy Brewing by Friday, April 11th at noon. The entry fee of \$60 (cash or check made out to City of Gretna) must be included and is non-refundable.
- All teams must be named. Have some fun with it! First come first serve for names, if a name is taken, we will let you know so you can change it.
- Teams must arrive between 11:30-12:45 pm to check in and place their pizza/ drink order. Each team's entry fee includes two (2) 12-inch pizzas and four (4) fountain drinks. Any additional food or drink purchases are the responsibility of the team. We recommend arriving early to order and eat so you can focus on the puzzle!
- Game Play will start promptly at 1:00pm and end at 3:00pm
- All team members must arrive before the competition begins. Otherwise, their team will have to proceed without them.
- No team will see the puzzle until the timer begins – the puzzle boxes will be placed face down on the table before the competition starts.
- There are no devices or outside assistance permitted while working on a puzzle.
- The City will have people to oversee – one to handle the timer and completion times, and another to observe and ensure that competitors are abiding by the rules. Both individuals will determine the winner, either by completion time or number of remaining pieces.
- Individuals and teams are not allowed to distract or approach team tables while the competition is in progress.
- In the event of a tie for first place in a division, tied teams can be given an extra 5 minutes to work on the puzzle.
- The City reserves the right to photograph the event for publicity/promotional purposes. All photos become the property of the City of Gretna.
- Teams will be allowed to keep their puzzle!
